- 3. The number of diagnoses in each year; 2020, 2021, 2022, 2023, 2024\* (\*to date)***
- 4. The number of shared-care requests made in each year; 2020, 2021, 2022, 2023, 2024\* (\*to date)***
- 5. The number of refused shared-care requests (i.e. where the patient's main healthcare provider has refused to take on the shared-care or equivalent) made in each year; 2020, 2021, 2022, 2023, 2024\* (\*to date)***

***If possible, please provide the data for all questions in relation to those via the right-to-choose only. If this is not possible for questions 2-5, please provide totals for your service.***
