**Your request for information under the Freedom of Information Act 2000**

Thank you for your request for information received on the 23<sup>rd</sup> November 2023. We can confirm that the Staffordshire and Stoke-on-Trent Integrated Care Board can provide the following information.

**Would you be so kind as to provide me with some information with regards to your contracts.**

**1. How is live in care commissioned? Does it go through a framework agreement? Is it spot purchased?**

Mixture of DPS and spot purchase. We have a dynamic purchasing tool (Adam) in place for care at home and some live in care requests are sourced via this tool. Any more specialist requirements are sourced via spot purchase.

**2. If it is only via a framework contractual arrangement when does that next open? Or does it remain open to new applicants?**

The DPS remains open to new applicants at all times, so there is no limit / closing dates.

**3. How do you select providers?**

Providers are chosen based on quality, cost and ability to meet care requirements.

**4. Is there a set weekly rate?**

No.

**5. Is it mandated that we have a local branch?**

It is not a mandatory requirement, however, in the absence of a local branch, assurance of local clinical oversight is required.

**6. Is it possible to give me an idea of how many packages of Live in Care you would typically commission?**

Unfortunately we do not record live-in care as a separate category, therefore we are unable to provide this information.

Should you require any further information or clarification regarding this response please do not hesitate to contact us. If you are dissatisfied with the response, you are entitled to request an internal review which should be formally requested in writing and must be within two calendar months from the date this response was issued.
