Please find a freedom of information request below for the following ICB organisation: NHS Staffordshire and Stoke-on-Trent Integrated Care Board (ICB):

- 1. Does the ICB commission, provide or manage any or a combination of these type of care services provided in peoples' homes?
  - a. A domiciliary care bridging service for hospital patients that are fit to leave hospital but need care services at home - this service would typically be provided for a short period of time until the patient's local authority can provide a more permanent service if needed.

This is not provided by the Continuing Healthcare service.

b. Re-enablement services for hospital patients discharged into the community so as to get them fit and healthy to look after themselves.

This is not provided by the Continuing Healthcare service.

# c. A long-term domiciliary care service

Yes, Domiciliary Care packages for End of Life, Continuing Healthcare and Joint Funded patients so they can be cared for within their own home.
