**This freedom of information request relates to the ICB's NHS Continuing Healthcare service, for adults.**

**I am interested in packages of care funded under NHS Continuing Healthcare that are provided in the service users own home. So these are most likely to refer to packages of care provided by home care agencies or domiciliary care provider.**

**Out of these packages of care I would like to know, currently:**

**a) How many packages involve the commissioning/funding of a nurse for 24 hours a day?**

We do not have any packages which involve the commissioning / funding of a nurse for 24 hours a day.

**b) How many packages of care fall within the cost bracket of £10,000 to £11,000 a week?**

Three

**c) How many packages of care fall within the cost bracket £11,000 to £12,000 a week?**

One

d) How many packages of care fall within the cost bracket of £12,000 to £13,000 a week?

Zero

e) How many packages fall within the cost bracket of £13,000 to £14,000 a week?

Zero

f) What is the budget/cost of the most expensive package of care? This can be weekly or annual budget, rounded to the nearest £1000 to avoid identifying the package by giving exact budget.
