**Your request for information under the Freedom of Information Act 2000**

Thank you for your request dated the 21<sup>st</sup> September 2022. We can confirm that Staffordshire and Stoke-on-Trent Integrated Care Board do hold the information that you have requested. Please see our responses in blue below:

**We are contacting you today to request information Chair and Chief Executive in the ICP under the Freedom of Information Act, including their full job titles and the names of individuals who hold these positions.**

**At IQVIA Medical Communications we take supporting your role in healthcare and research as a top priority. OneKey is a trusted healthcare professional and healthcare organisation data source for life sciences in UK and Ireland. OneKey covers 1.5 million hospitals, medical offices, health-related institutions, and nursing homes in more than 100 countries and thousands of health care providers like you.**

**One of the top priorities of IQVIA is protecting the data of people and companies in the healthcare sector. Ensure streamlined interactions with pharmaceutical stakeholders. Receive safety warnings and drug notifications and recalls in a timely manner and enable efficient survey and clinical trial enrolment.**

As set out by statute, the ICP is a Joint Committee formed out of Staffordshire and Stoke-on-Trent ICB and Stoke-on-Trent / Staffordshire Councils; who are the chairs of the committee meeting, on a rotational basis. The ICP is not an organisation so does not employ a CEO or a Chair. Instead, Chief Executive Officers and Chairs are employed by each of the statutory partners comprising the wider Integrated Care System – ICB, Councils and NHS Providers. Details of whom are present on all their websites, so will not be released under S.21 of the Freedom of Information Act.
