Thank you for your request for information received on the 30th March 2023. We can confirm that the Staffordshire and Stoke-on-Trent Integrated Care Board does hold the information that you have requested. Please see our responses in blue below:

Under the Freedom of Information Act, I would like to request the FOI email addresses for all of the sub-ICB locations (SICBLs) within the ICB. This is to address situations where data is not held by the ICB and so there is a need to request information at SICBL level rather than ICB level.

To be clear, by SICBL I am referring to what was previously called 'CCGs' until 1 July 2022. By FOI email addresses, I am referring to the email addresses that each SICBL holds for people to send freedom of information requests to. For example, within Greater Manchester ICB there are ten separate email addresses for each of the SICBLs (former CCGs) e.g. Bolton - gmicb-Bol.foi@nhs.net; Oldham - oldccg.foi.oldham@nhs.net; Salford - gmicb-sal.foi@nhs.net etc.
