Please provide data on the amount of NHS dental domiciliary care commissioned (in Units of Dental Activity) within NHS Staffordshire and Stoke-on-Trent ICB in the 2022/23 and 2023/24 financial years, alongside estimates/plans for the 2024/25 financial year

- All domiciliary care across Staffordshire & Stoke-on-Trent ICB is provided by the Staffordshire Community Dental Service. This activity is not commissioned in units of dental activity, so we do not hold the required data. We don't hold the data for 22-23 financial year as that was pre-delegation. - We don't hold the data for 23-24 for UDAs data for a service that doesn't work on counting UDAs (community dental services don't) means that we don't hold the data either, now or for the future. That activity data is recorded under a different contractual mechanism, meaning that we can't provide the data in UDA format, as requested
