Thank you for your request dated the 8<sup>th</sup> March 2023. We can confirm that the Staffordshire and Stoke-on-Trent Integrated Care Board does hold the information that you have requested. Please see our responses in blue below:

Health Harmonie Limited

**3. Have the CCGs that covered the ICB pre-June 2022 or the ICB ever been to procurement for community dermatology?**

Yes the Health Harmonie service was subject to competitive procurement. This excludes the historical footprint of East Staffordshire CCG (ESCCG). Pre ICB ESCCG did not go out to competitive tender as their activity for now currently remains within the Acutes.

**4. When did the service start?**

1<sup>st</sup> June 2021.

**5. What was/is the annual spend?**

£4,137,900 for 2022/2023 as per contract.
