Thank you for your request for information received on the 19th February 2024. We can confirm that the Staffordshire and Stoke-on-Trent Integrated Care Board can provide the following information.

Under the Freedom of Information Act 2000, could Staffordshire and Stoke on Trent ICS provide the following information:

For the 2022 / 23 financial year (between 1st April 2022 and 31st March 2023), what was (a) the total value (£) of Staffordshire and Stoke on Trent ICS's capital spend, and (b) the total value (£) of external vendor contracts commenced by Staffordshire and Stoke on Trent ICS during the FY22/23 period, relevant the following areas:

- (a) Cloud migration of patient data.***
- (b) The consolidation of patient information systems to support interoperability***
- (c) The development of performance analytics dashboards.***
- (d) All tools within NHS services and clinician decision support***
- (e) The secure storage and transfer of NHS patient data.***

The total capital spend for 1st April 2022 and 31st March 2023 will be £1.638m. The total value of vendor contracts commenced during the financial year 2022/23 will be £0.492m.

The ICB does not hold the information at the level of detail requested in points a-c. For information requested under points d-e, you would need to contact the relevant Trusts to obtain this information.
