Thank you for your request dated the 8th August 2022. We can confirm that Staffordshire and Stoke-on-Trent Integrated Care Board does hold part of the information that you have requested. Please see our responses in blue below / attached:

Under the Freedom of Information Act I would like to request the following information regarding the financial efforts of your NHS Integrated Care Board to promote diversity.

- 1. The total funds you received when operating as a CCG from NHS England between 2017 – 31st June 2022? I would like this broken down for each financial year.**

This information is within the published annual accounts contained within the individual CCG's annual report. It is to be found within the 'Financial Performance Targets' note to the accounts under NHS Action Section '223I (3) Target value.

- 2. The total funds your CCG allocated to the provision of secondary and tertiary care between 2017-present? I would like this information broken down for each secondary or tertiary care setting (for example for each hospital) and for each financial year.**

We would refer you to the email sent from the FOI Team on the 18th August 2022 seeking clarification whether by tertiary care setting you mean the voluntary selector only for which a response has not been forthcoming.

Accordingly, this question has not been completed. Should you still require this information please submit a new FOI request which will be processed in the normal way.
