Thank you for your request dated the 18<sup>th</sup> October 2022. We can confirm that the Staffordshire and Stoke-on-Trent Integrated Care Board does hold the information that you have requested. Please see our responses in blue below:

**I am contacting you because I need to gather information from your 2021/22 Account Annual report or the merged CCG's (Clinical Commissioning Groups). I tried your "Publication Scheme" section but could not get anything from there and the CCG's websites are down as well.**

**By assuming NHS Staffordshire and Stoke-on-Trent Integrated Care Board (ICB) was created in July 2022, I believe you still do not have an Accounts Annual Report (or Statement of Accounts) to provide. If you have, I will appreciate if you can send it to me (or provide website link).**

**If the first option is not possible, can you please provide the 2021/22 Annual Reports from the CCG's (Stoke on Trent CCG, North Staffordshire CCG, Stafford Surrounds CCG, Cannock Chase CCG, East Staffordshire CCG, South East Staffordshire and Seisdon Peninsula CCG).**
