**Your request for information under the Freedom of Information Act 2000**

Thank you for your request for information received on 16<sup>th</sup> June 2025. We can confirm that the Staffordshire and Stoke-on-Trent Integrated Care Board can provide the following information.

An anonymised copy of this response will be made publicly available on the ICB website. Please note the ICBs responses in blue.

- 1. How much Section 106 or CIL funding is currently held unspent by the ICB?**  
The money currently held by the ICB, which is as yet unspent = £15,242, which was received from a local authority in February 2025.
- 2. How much Section 106 funding was transferred from local authorities to the ICB in a) 2024/25, b) 2023/24, and c) 2022/23?**  
In 24/25 £63,146.36 was transferred from local authorities to the ICB.  
  
£0 was transferred from local authorities to the ICB in the years 22/23 and 23/24.
- 3. How much CIL funding was transferred from local authorities to the ICB in a) 2024/25, b) 2023/24, and c) 2022/23?**  
£0 of CIL funding was transferred from local authorities to the ICB across these periods.
- 4. How much Section 106 funding did the ICB request to be transferred from local authorities in a) 2024/25, b) 2023/24, and c) 2022/23?**  
The ICB requested the sum of £47,904.36 be transferred from local authorities across these periods.
- 5. How much Community Infrastructure Levy (CIL) funding did the ICB request to be transferred from local authorities in a) 2024/25, b) 2023/24, and c) 2022/23?**  
£0 of CIL funding was requested to be transferred from local authorities across these periods although during these periods 1 unsuccessful and 1 successful bids were made for CIL funding with a grant agreement pending for the successful bid, which was confirmed in February 2025 for the total sum of £1,152,110.
- 6. Since April 1, 2022, how many times have local authorities declined the ICB's requests for the transfer of developer contributions (Section 106 or CIL funds)?**  
Local authorities have not declined a request to transfer developer contributions across this period.

7. For each case where a local authority declined a request for developer contributions since April 1, 2022, please provide a) the reason for the refusal and b) the amount of money requested.

In cases where formal requests have been made during the planning process (and the scheme has obtained planning permission) to secure developer contributions but have been declined these have been due to the reason of the scheme either being financially unviable or the view has been taken by the determining authority that the request to support infrastructure would not meet the relevant tests contained within the CIL regulations and have therefore not been secured.

There are 7 cases where the request has not been secured with a value totalling £184,676 across these cases.

8. Has the ICB ever reallocated any Section 106 or CIL funds originally designated for one project to another project? If so, please provide details of the amounts and reasons.
