Thank you for your request for information received on the 11th April 2024. We can confirm that the Staffordshire and Stoke-on-Trent Integrated Care Board can provide the following information.

Please set out how much money your integrated care board spent on hospice care for children and young people with life-limiting or life-threatening conditions between 6 April 2023 and 5 April 2024. Please provide a total, in addition to a breakdown of funding per children's hospice organisation.

A total of £182,615 - £117,101 Douglas Macmillan Hospice plus £65,514 Acorns.

2. Please set out the arrangement through which this money was paid in 2023/24 – was this by standard contract, service level agreement, grant arrangement, spot purchases or by other means.
