Your request for information under the Freedom of Information Act 2000

Thank you for your letter of the 30th June 2022 and your subsequent email of the 1st August 2022 in which you raise a number of questions relating to the design of the Staffordshire and Stoke-on-Trent Integrated Care Partnership (ICP).

I agree that it is important for each ICP to take an inclusive approach to its design and membership in order that it can be best connected to the people and the communities across the Integrated Care System (ICS).

In Staffordshire and Stoke-on-Trent, we have taken time and care to work collectively across partners to establish an ICP that gives this connectivity balanced against the need for proportionate representation.

The ICP is a joint committee of both Local Authorities and the Integrated Care Board (ICB) with a focus on leading and delivering the Integrated Care Strategy and system outcomes for the ICS. It includes representation from a wide and diverse range of partners including NHS, Local Authority (upper tier, district and boroughs), Voluntary Sector and other public bodies. The Local Authorities will contribute their own perspective as well as an assessment of the market more generally. This is equitable with the arrangements for the NHS.

The Integrated Care Board (ICB) has published a People and Communities Strategy which details our approach to engagement activity across our partners, stakeholders and the public. This was developed in consultation with a wide range of contributors and can be accessed through our website at https://staffsstokeicb.nhs.uk, the website also has a 'Get Involved' section which provides more detail on how people, communities and groups can contribute to the work of the ICB.

In respect of 'Place', we have collective agreement across our ICS partners that 'Place' will be aligned to upper tier Local Authority boundaries. The exact nature of these arrangements remains in development and during that period, the ICB will retain responsibility for the delivery of all statutory duties.
