I am currently looking for the most up to date version of your fertility clinical commissioning policy. I understand that the below document was your draft interim policy that was under review, and you were inviting the public to provide feedback.

Is this the document currently used in the NHS Staffordshire and Stoke-On-Trent area, or has it been updated?

The Staffordshire and Stoke-on-Trent ICB currently work to three Assisted Conception policies dependent on where patients live (please see links below). These were inherited from the Clinical Commissioning Groups that the ICB took over from.

The ICB ran an involvement exercise through March 2023, which was an opportunity for stakeholders, patients and the public to share their views on the ICB's draft interim Infertility and Assisted Conception Policy. A report of findings from the involvement has been developed and a further review of the draft policy has been undertaken. The final draft Staffordshire and Stoke-on-Trent Infertility and Assisted Conception Policy will be discussed at the ICB Board during winter 2023/2024 and the full details can be found at **Board meetings - Staffordshire and Stoke-on-Trent, Integrated Care Board (icb.nhs.uk)**.
