In your ICB's remit, please could you confirm the total number of people waiting for the following treatments and the mean average waiting time for each:

- Diagnostic Hysteroscopy
- Hysteroscopic removal of polyp
- Hysteroscopic removal of submucous fibroid
- Laparoscopic surgery for hydrosalpinges
- Laparoscopic surgery for fibroids or endometriosis
- Laparotomy for fibroids

For each of the above, please could you also confirm the percentage of people waiting more than 18 weeks since referral for treatment?
