Thank you for your request dated the 15th February 2023. We can confirm that the Staffordshire and Stoke-on-Trent Integrated Care Board does hold the information that you have requested. Please see our responses in blue below:

I have been unable to find all of the information I have been looking for in relation to the NHS Staffordshire and Stoke-on-Trent ICB fertility/assisted reproduction policy from your website or from previous FOI requests. Can you please provide the following information:

- 1. The <u>Fertility policy</u> currently available on the website is past the review date (March 2021) What policy is currently in use and can I get an electronic copy?
- 2. If the policy is currently under review, what policy is currently used if someone would like to access fertility treatment on the NHS?
- 3. Does the same policy cover the entire catchment area of the ICB?

The Staffordshire and Stoke-on-Trent Integrated Care Board is in the process of aligning the historic CCGs' IVF policies. In the absence of an aligned interim policy, we are currently working to three separate policies. The policies are available on our website (links below):
