Thank you for your request dated the 10th November 2022. Please be advised that the Integrated Care Board do not hold the information for the Integrated Care System which is not a statutory body. We have therefore provided the information relating to the Staffordshire and Stoke-on-Trent Integrated Care Board. Please see our responses in blue below as below:

I am writing with a Freedom of Information request regarding the provision of virtual ward care within your ICS. We would like to get the following data on the contracts your ICB has with independent providers:

- 1. Do you use virtual wards in your trusts? (Y/N)
- 2. If you are not currently using virtual wards, are you planning on using them in the future?
- 3. How many virtual ward beds do you have?
- 4. Can you please specify how many virtual wards you have by speciality (respiratory care, cardiology care, diabetes care, stroke care, renal care, pre/post operative care services, other)?
- 5. How many patients have been admitted in virtual wards in 2017, 2018, 2019, 2020, 2021, and 2022?
- 6. Which virtual ward software providers do you work with?
- 7. Do you have the values and durations of the contracts with the virtual ward software providers for 2019, 2020, 2021 and 2022?
