5. What mental health support do you offer for people affected by miscarriage?

The Lotus Service is commissioned as a partnership between North Staffordshire Combined Healthcare NHS Trust and Midlands Partnership University NHS Foundation Trust. Launching in 2021, it delivers mental health support to those, including partners / fathers, who are living through pregnancy and baby loss, birth trauma and tokophobia (fear of childbirth), with referrals being made by appropriate health professionals.
