- Demonstration of the ability to mitigate Clinical Risk between Prescribing and Dispensing
- Indemnity Arrangements
- Ability to support the IP(s) to participate in MDT, peer support.
- Track record of successful Services Delivery Both National and Local

# 6. Please provide details of much will those (i.e. a contractor) receive for taking part in the Pathfinder programme including any set up payment, monthly payments etc.

The published figure of £49.44 per hour. Each pathfinder can claim for up to 24 sessions per month (each session is 4 hours = £198) when they start providing the Pathfinder programme. They also receive a set-up fee of £1500.
