## FOI FOI-09-101: Your request for information under the Freedom of Information Act 2000

Thank you for your request dated the 5<sup>th</sup> September 2022. We can confirm that Staffordshire and Stoke-on-Trent Integrated Care Board does hold the information that you have requested. Please see our responses in blue below / attached:

Agepha Pharmaceuticals has Aciclovir Agepha 3% eye ointment available in the UK for herpetic keratitis. At present there is no other Aciclovir available in the UK, since Zovirax GSK was discontinued in 2018.

We would therefore like to a reach out and ask if the product is available in the formulary and if not what's the procedural inclusion steps into the formulary, which will allow healthcare professionals to prescribe Aciclovir.

# I would be grateful if you could forward my Email to the relevant department or share the contact details of whom I should contact.

The ICB Medicines Optimisation Team is already in discussions with the University Hospitals of North Midlands NHS Trust (UHNM) Ophthalmology Team Specialists to determine the place in therapy of this preparation on the Staffordshire formularies. Discussions / papers are then taken to the Area Prescribing Committee and Group in Common (APCG) to determine formulary inclusion and if included, to then assign a Red/Amber/Green (RAG) rating.
