**Is your Integrated Care Board aware of the recently published NHS England publication titled "Optimising personalised care for adults prescribed medicines associated with dependence or withdrawal symptoms: Framework for action for integrated care boards (ICBs) and primary care"? **If so, what action will your Board take to:**

- a) Provide appropriate withdrawal services (not inappropriate substance misuse services) for patients who have become dependent, through no fault of their own, to prescribed drugs identified in the recent PHE review, such as benzodiazepines, z drugs, opioid containing drugs, antidepressants and pregabalin and gabapentin?**

The ICB has no plans around the publication at this present time.
