Your request for information under the Freedom of Information Act 2000

Thank you for your request for the ICB to review the response sent on the 18th January 2024 in respect of your FOI request of the 16th January 2024 regarding question one below which you have advised should read:

1. The number of doctors currently registered on your procurement / purchasing system, rather than the number of doctors eligible to undertake MHA assessments.

We can confirm that the Staffordshire and Stoke-on-Trent Integrated Care Board can confirm that the original response to question one has been changed as below:

The ICB has implemented the app from January 2024 so no information is available yet.

9. In 2023 what was the number of claims made in relation to patients who are registered with a GP in your geography but were assessed within the boundaries of another ICB (out of area patients)?

10. Where doctors undertake MHA assessments what is the standard fee (in 2023) you pay them?

£173.37

Do you make payment to the doctor where an assessment cannot be completed (but the doctor attends the arranged location)? (if so, is this at the same rate?)

Yes -25% of the standard fee.

11. Do you make payment for mileage incurred to undertake assessments? If so, what is the rate (in 2023)?

Yes – 59 pence per mile for the first 3,500 miles per year and 24 pence per mile thereafter.

12. Is the same mileage rate paid to doctors under contract (if you have any) as for ad hoc assessments?

Not Applicable.
