**I am currently collating some information in order to update a national training plan. As part of this process, I need to identify which staff will requires Tier 1 & Tier 2 Oliver McGowan Mandatory training.**

**The information I require is as follows:**

- 1. Local training offer to Providers of Supported living, domiciliary care, and Extra Care within your organisation in relation to mandatory training requirements.**

Our lead Trainer can deliver the TTT Tier 2 of the Oliver McGowan Training on Learning Disabilities and Autism.

- 2. Do you provide or support providers to achieve mandatory training?**

Once all trainers are qualified, they be given access to NHS Futures Oliver McGowan with access to 'Frequently asked Questions', materials etc.
