The ICB has implemented the app from January 2024 so no information is available yet.

**11. Where doctors undertake MHA assessments what is the standard fee (in 2023) you pay them?**

£173.37

**Do you make payment to the doctor where an assessment cannot be completed (but the doctor attends the arranged location)? (if so, is this at the same rate?)**

Yes – 25% of the standard fee.

**12. Do you make payment for mileage incurred to undertake assessments? If so, what is the rate (in 2023)?**

Yes – 59 pence per mile for the first 3,500 miles per year and 24 pence per mile thereafter.

**13. Is the same mileage rate paid to doctors under contract (if you have any) as for ad hoc assessments?**

Not Applicable.
