Thank you for your request dated the 10th February 2023. We can confirm that the Staffordshire and Stoke-on-Trent Integrated Care Board does not hold the information that you have requested. Please see our responses in blue below:

I would like to request some information as allowed under the Freedom of Information Act.

- 1. On the 1st January, how many people from your ICS area who had been referred to an NHS memory service had not yet had an attended first contact? Please can this number be provided for the years 2021, 2022 and 2023, and broken down by the following waiting times between their referral date and 1st January in the given year:**
 - a) 6 weeks or less**
 - b) greater than 6 weeks and less than or equal to 3 months**
 - c) greater than 3 months and less than or equal to 6 months**
 - d) greater 6 months and less than or equal to 12 months**
 - e) greater than 12 months and less than or equal to 18 months**
 - f) greater than 18 months and less than or equal to 24 months**
 - g) greater than 24 months**
