I would like to understand the number of serious incidents or never events that have been recorded by ophthalmology departments in relation to missed follow up appointments for wet AMD or glaucoma monitoring. By Missed I mean delayed or remaining unbooked for hospital reasons such as lack of capacity rather than patient cancellations.

If it is possible to have this for the 2022/23 year versus 2023/24 year to date please. If you represent more than one ICB - please can you supply for all.
