Your request for information under the Freedom of Information Act 2000

Thank you for your request for information received on the 14th November 2023. We can confirm that the Staffordshire and Stoke-on-Trent Integrated Care Board can provide the following information.

An anonymised copy of this response will be made publicly available on the ICB website.

Please see our responses in blue below:

I am currently focussing on Minor and Urgent eyecare services. I recently enquired from the ICB regarding the provision of Minor and Urgent eyecare in the community for which a response was provided.

From the queries I raised there was one very exciting response regarding equality of provision:

The ICB recognises that legacy commissioning arrangements have resulted in variation of service provision across Staffordshire and Stoke-on-Trent (SSOT). SSOT currently exploring options on how to harmonise MECS/CUES services across our footprint.

I was wondering if you were able to provide me any more details regarding this, whether there were engagement opportunities for Primary care optometry at all, also whether there was a timescale for these harmonised solutions (mindful of where we are in the financial year 2023/2024).

Proposals for changes to service provision are subject to the ICB governance processed and as such we are unable to provide details, including timescales, currently.

Regarding engagement opportunities for primary optometry, there has been extensive engagement through the Local Eye Health Network (LEHN) regarding pathways and

models of care, including the expansion of the MECS/CUES services. The LEHN comprises a range of clinicians including Staffordshire Local Optical Committee who represent local Optometrists.
