Your request for information under the Freedom of Information Act 2000

Thank you for your request dated the 7th November 2022. We can confirm that the Staffordshire and Stoke-on-Trent Integrated Care Board does hold the information that you have requested. Please see our responses in blue below

We write in relation to Walley's Quarry Landfill located on Cemetery Road, Newcastle-under-Lyme, Staffordshire ST5 6SB (hereafter referred to as the Landfill). We understand that the site is operated by Walley's Quarry Ltd (formally known as Red Industries Ltd).

We would like to make a Freedom of Information Request for the following information in relation to the Landfill:

1. All data you have collated in relation to GP consultations and NHS 111 calls in Staffordshire where the complaints have been linked to the aforementioned Landfill?

No data has been collated as described by the ICB.

2. Confirmation of the date when you first become aware of the potential health impact the pollution from the Landfill could have to the local community?

The ICB do not hold this information.

3. Confirmation of any action you have taken in relation to the Landfill?

No actions has been taken by either the Staffordshire and Stoke-on-Trent Clinical Commissioning Groups (CCGs) nor the Staffordshire and Stoke-on-Trent Integrated Care Board (ICB). The health response was led by the UK Health Security Agency.

4. Confirmation of any actions you have recommended in relation to the Landfill?

None.

5. Confirmation of any official complaints made by members of the public to you regarding the Landfill?

No complaints have been received for either the CCGs or the ICB.

 - The Word Health Organisation in relation to the odour and pollution coming from the Landfill?
 - Newcastle-under-Lyme Borough Council and Staffordshire County Council in relation to the odour and pollution coming from the Landfill;
 - Walley's Quarry Landfill Liaison Committee in relation to the odour and pollution coming from the Landfill?

Neither the ICB nor the CCGs have held meetings with any of the organisations listed to this issue.
