Is your ICB actively seeking to increase the number of GP practices in the area that are visa sponsors? If so, how?

The Staffordshire Training Hub launched the GP Skilled Worker Visa Sponsoring practice programme in December 2022 to support Practices with the Home Office costs of up to £3,000 to be claimed retrospectively towards the costs of a licence, renewal licence fee or the GP Certificate if Sponsorship (CoS) fee and to date we have supported 23 x GP Practices.
