**Your request for information under the Freedom of Information Act 2000**

Thank you for your request dated the 14<sup>th</sup> July 2022. We can confirm that Staffordshire and Stoke-on-Trent Integrated Care Board do not hold the information that you have requested. Please see our responses in blue below / attached:

**Can you provide a statistical summary of the resources available to the residents of Lichfield and Burntwood (Lichfield District Council area) through their registered GP practices?**

**This data does not appear to be publicly available but of course should be an integral part of the management of resources by the CCG hence readily available.**

**We would like to have data of full time, part time and full-time equivalent employees and partners classified by:**

- a) Partner GPs
- b) registrars
- c) other GPs
- d) Advanced Nursing practitioners
- e) Nurses by grade
- f) Other medical professionals eg Physiotherapists, pharmacists detailed as appropriate)
- g) Non-medical support staff, receptionist, clerical support

**(You will have a better understanding of the personnel structure of general practice and if you have your own better classification, please provide that).**

**We would like this broken down by the lowest geographical grouping possible, at least to distinguish between Lichfield, Burntwood (city and town areas) and rural areas.**

**Can you also supply the appropriate numbers of registered patients for the geographical groups you identify? Also, if you have them, the relevant population figures you use for planning purposes and any other figures which you believe would help in the interpretation of the data requested - for example national or regional averages.**

The Staffordshire and Stoke-on-Trent Integrated Care Board do not hold the information requested. Please refer to the NHS digital contracts (click on link below):

where the latest key facts on national statistics and staff group breakdown at practice level is available. However, the practice level would require downloading the raw data and filtering to the required practices for those two Primary Care Networks covering Lichfield and Burntwood or practices covering wider areas.

The data extract also provides details for total number of patients for the practices. Alternatively, the website provides an interactive dashboard with various interactive charts displaying different characteristics of staff and data can be drilled down to practice level.

Practices are independent contractors and can determine locally what workforce information they publish on their websites. The Staffordshire and Stoke-on-Trent Integrated Care Board utilises data from the above website when undertaking any workforce planning.

National population figures are also published on NHS Digital and a breakdown by practice as at the 1<sup>st</sup> April 2022 is shown below.
