Thanks for sending this through. We'll have a look through to make sure we have everything we need. We're just sending a message out to all PCNs and Practices to let them know that we're not going to review any requests for additional space until the PCN Estate Plan process has completed. This is because we've got a lot of requests for additional space that will have an impact on our revenue budget and we don't get any uplifts in this budget nationally unfortunately. We're therefore going to consider all applications at one time and we'll prioritise them based on the outcomes of the PCN Estate Plan process (which does have Practice level information in there). We're expecting this to be around October time. This was the fairest and most equitable way we felt we could manage this with the limited funds we have.
