To enable care providers to work effectively with Integrated Care Boards (ICBs) to meet their Environmental, Social and Governance (ESG) commitments, the following information request looks to establish key information critical for Adult Social Care (ASC) providers to support ICBs to meet those commitments.

#### **Questions**

1. Please provide your ICB definition for "local" in regard to the procurement of goods and services. *Note: if you do not have a specific definition, please offer guidance to ASC providers as to how they should consider this in regard to supporting your ICB.* 

Generally speaking, local refers to the "Staffordshire and Stoke on Trent" geographical footprint. For example, our procurement policy refers to local policies, plans, local authorities. These would all be those within our geographical footprint.

2. Please provide your ICB definition for "minority" in instances such as minority-owned businesses and similar contexts. *Note: if you do not have a specific definition, please offer guidance to ASC providers as to how they should consider this in regard to supporting your ICB.* 

As an ICB we do not have a definition of "minority".
