Provider Collaborative Partnerships are developing across our system Portfolios and Enabling workstreams as the key vehicle for delivery of some system priorities at scale across more than two providers. The Provider Collaborative Programme Board supports and oversees the development and mobilisation. The Provider Collaborative Programme Board is a partnership with Executive representation from Providers, ICB and Local Authorities.
