Thank you for your request for information received on the 14th February 2024. We can confirm that the Staffordshire and Stoke-on-Trent Integrated Care Board can provide the following information.

I would like to request the following records under the FOI act.

I would like to know whether you will be directly commissioning the 59 services that are being delegated to you from April 2024 or if you're going to be commissioning as part of a collaborative.

If it will be as part of a collaborative, I'd like to know the identity of the other members of the collaborative and its name.

And I would like to know the name of the accountable officer for commissioning each of the services, and the names of those sitting on any commissioning committee or equivalent body.

The 59 Specialised Services that are due to be delegated to ICBs (subject to ICB board approval) in April 2024 will be commissioned jointly with other ICBs. The approach in the Midlands is to jointly commission specialised services on an East Midlands and West Midlands footprint.

These formal parentships will be governed through a Joint Committee are as follows:
