Thank you for your request for information received on Friday 21<sup>st</sup> February 2025. We can confirm that the Staffordshire and Stoke-on-Trent Integrated Care Board can provide the following information.

I hope this message finds you well. I am emailing to request information under the Freedom of Information Act. Would you be kind enough to provide information on your weight management pathways, specifically on the below queries please?

1. Do you have a single point of access or triage service? If so, what are the current wait times?  
Staffordshire and Stoke-on-Trent (SSOT) have a triage service for patients that reside in the North of the County for specific areas of health, weight management is not of those health areas.
2. Do you offer a tier 3 weight management service?  
Tier 3 provision is currently based on previous CCG historical arrangements and is available in both the Southwest and South East of SSOT.
3. What are the wait times for your weight management services?  
SSOT ICB does not hold that information it would need to be request from our providers of care who are University Hospital North Midlands, The Royal Wolverhampton Trust and Midlands Partnership University Foundation Trust.
4. Do you have an injectables pathway? If so, what are the wait times for this service?  
SSOT ICB does not hold that information it would need to be request from our providers of care who are University Hospital North Midlands, The Royal Wolverhampton Trust and Midlands Partnership University Foundation Trust.
