Thank you for your request for information received on 5th December 2024. We can confirm that the Staffordshire and Stoke-on-Trent Integrated Care Board can provide the following information.

1. Does your ICB currently offer Tier 3 weight management services?

Staffordshire and Stoke-on-Trent's (SSOT) Weight-related Interventions Tailored in Care for Health (SWITCH) is a specialised service to support people with managing the many contributing factors that can make reaching lifestyle and/or weight goals difficult. This service doesn't currently prescribe.
